**GRANDFLASH Crystal** characterized by good bonding strength with the layered materials such as PDCPD (Telene®), viniloester, epoxy resins and glass reinforced plastic, epoxy resin, with the majority of synthetic polymeric materials and metals, steel and aluminium. Slight heat during thermal reaction allows bonding especially of thin materials. Thus, for example, when bonding facade structures of the material Alucobond® there are no surface damage.

**GRANDFLASH Crystal** is ideal for bonding components of small and medium sizes. Perfect for bonding transparent surfaces (glass and transparent plastics), which is especially appreciated in the production of outdoor advertising lights, in the production of boxes, shelves, benches for reading, etc. Also suitable for bonding wood and stone. Very easy to use thanks to the packaging in syringes.
